Vocational Training for adults and pre-vocational training for children are being provided in the following skills.

- a) Chalk Making b) Candle Making c) Greeting Cards Making d) Paper Cover Making
- e) Envelops Making f) Block printing g) Gardening h) Yoga i) Training in sports and Gymnasium j) Paper plate making .

The paper covers are being supplied to HOPCOMS. The chalk pieces are supplied to nearby Government and private schools. The candles are being supplied to Treat restaurant and parents.

2. NIOS (National Institute for Open University) . Coaching children with mentally retardation for 10th standard with in a period of 3 to 5 years through NIOS Scheme .This program covers children with Mild Mental Retardation, Cerebral Palsy, Autism and Multiple Disabilities. Continuation of education and vocational training for children and adults with Mental Retardation only through National Institute for Open University .

3. **Out Reach Program:** This program is supported by Action V, Germany by meeting the salaries of two teachers and one physiotherapist. Under this program 30 disabled children integrated in 11 schools around our centre are covered. All Government benefits such as Scholarship, Identity Card, Disability Certificate, Assistive Devices and Railway Concession Forms duly signed by authorized Medical Practitioners are made available to these children. 46 Children have been awarded scholarship by the Department of Women and Child Welfare, Govt. of Karnataka, for the year 2014-15 with the help of WARDS out of which 6 children are from outreach program.

I am very sorry to report repeatedly that no grant has been received from Central Government in spite of our continuous efforts in this direction. Application for grant under child centre scheme was submitted in July 15 and inspection by department official is awaited.

- a) Successful implementation of all the services mentioned above with all strain and stress is the achievement during this year.**
- b) The WARDS management have successfully constructed the 1st floor with 2big class rooms and 1 office block with the support of public , donors and philanthropist . It has also constructed a barer free and friendly toilet for the disabled children who are studying in WARDS. The renovation of old building will be taken up by the management to provide a decent kitchen and dining hall for our children who are studying in WARDS. Thanks to all donors who supported for the welfare of the disabled children studying in WARDS.**
- c) Awareness was created on the products made by our disabled children at WARDS in various Software companies and other public places through organized exhibitions.**
